Comes now the undersigned and states that he is informed and believes, and upon such information and belief declares: That on or about 03/21/2017 at and in the City of Los Angeles, in the County of Los Angeles, State of California, a misdemeanor, to wit, violation of Section 370/372 of the California Penal Code was committed by the above-named defendant(s) (whose true name(s) to affiant is(are) unknown), who at the time and place last aforesaid, did willfully and unlawfully maintain and commit a public nuisance by acts which were injurious to health, and were indecent, and offensive to the senses, and an obstruction to the free use of property, so as to interfere with the comfortable enjoyment of life and property by an entire community and neighborhood, and by a considerable number of persons, and did willfully and unlawfully obstruct the free passage and use, in the customary manner, of a public park, square, street and highway.

#### COUNT II

For a further, separate and second cause of action being a different offense, belonging to the same class of crimes and offenses set forth in Count I hereof, affiant further alleges that on or about 05/18/2017 at and in the City of Los Angeles, in the County of Los Angeles, State of California, a misdemeanor, to wit, violation of Subsection (a) of Section

422 of the California Penal Code was committed by the above-named defendant(s), (whose true name(s) to affiant is(are) unknown), who at the time and place last aforesaid, did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to another person, to wit, CONFIDENTIAL, with the specific intent that the statement, made verbally, in writing, and by means of an electronic communication device, was to be taken as a threat, even if there was no intent of actually carrying it out, which, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate, and specific as to convey to the person threatened a gravity of purpose and an immediate prospect of execution of the threat, and thereby caused that person reasonably to be in sustained fear for his or her own safety and for his or her immediate family's safety.

# Investigation

My partner and I approached the apartment complex and met with the Victim/PR Scroggin, Terrance who stated Suspect, Perelman, Kevin scattered hundreds of business cards on Burbank Blvd. and Julianna Pl. and has done so several times in the past. Victim gathered approximately 50 business cards off the ground on Burbank Blvd. and set them on the suspects patio table ( ). Victim and Suspect crossed paths outside their complex on Julianna Pl. and the Suspect approached the Victim. Suspect got inches away from the Victims face and threatened the Victim. Suspect stated he would "Slice him open if he did that again." Victim told Suspect it needed to stop and walked away. In fear for his life, Victim called PD. Victim believes Suspect would carry through on his threat.

Witness 1, Kotel, Yruhm stated he has trouble understanding English but was standing on his porch when he saw the Suspect approach the Victim and get inches from his face. Witness stated he had a confrontational stance and looked like he was going to fight him.

Unit 21A43, Officer Campodonico #26541, Officer Norris #37704 responded as well as Sgt. Schnieder #32410. Officer Dinse 34920 and MEU Officer Jurisaga #36897 coincidently responded to the location to conduct a mental evaluation assessment of the suspect and was prearranged prior to the call being dispatched. We made a tactical plan and approached the residence. My partner and I knocked on the Suspect door, the Suspect answered the door and sat down on the chair on the patio of his residence. Suspect stated the Victim had been following him around and antagonizing him. Suspect denied making a threat to the Victim. Suspect was then handcuffed and taken into custody without incident.

Perelman was placed under arrest for 422 PC Criminal Threats and transported to Topanga Station.

# Investigation

My partner and I approached the apartment complex and met with the Victim/PR Scroggin, Terrance who stated Suspect, Perelman, Kevin scattered hundreds of business cards on Burbank Blvd. and Julianna Pl. and has done so several times in the past. Victim gathered approximately 50 business cards off the ground on Burbank Blvd. and set them on the suspects patio table (21260 Burbank Blvd. #18). Victim and Suspect crossed paths outside their complex on Julianna Pl. and the Suspect approached the Victim. Suspect got inches away from the Victims face and threatened the Victim. Suspect stated he would "Slice him open if he did that again." Victim told Suspect it needed to stop and walked away. In fear for his life, Victim called PD. Victim believes Suspect would carry through on his threat.

Witness 1, Kotel, Yruhm stated he has trouble understanding English but was standing on his porch when he saw the Suspect approach the Victim and get inches from his face. Witness stated he had a confrontational stance and looked like he was going to fight him.

Unit 21A43, Officer Campodonico #26541, Officer Norris #37704 responded as well as Sgt. Schnieder #32410. Officer Dinse 34920 and MEU Officer Jurisaga #36897 coincidently responded to the location to conduct a mental evaluation assessment of the suspect and was prearranged prior to the call being dispatched. We made a tactical plan and approached the residence. My partner and I knocked on the Suspect door, the Suspect answered the door and sat down on the chair on the patio of his residence. Suspect stated the Victim had been following him around and antagonizing him. Suspect denied making a threat to the Victim. Suspect was then handcuffed and taken into custody without incident.

### Arrest

Perelman was placed under arrest for 422 PC Criminal Threats and transported to Topanga Station.

# Source of Activity:

I, Senior Lead Officer Dinse #34920, am currently assigned Topanga Patrol and responsible for monitoring the east portion of Woodland Hills. My responsibilities as a senior lead officer include handling radio calls, monitoring crime trends, mitigating traffic issues, creating neighborhood watch groups, intervening on neighbor disputes and dealing with on-going nuisance issues. One of these nuisance issues includes a community complaint I've been dealing with for the past 5 years. The suspect in this case, Kevin Perelman is known to throw mass amounts of business cards throughout Woodland Hills creating a nuisance.

Kevin Perelman suffers from extreme mental illness and believes there is a conspiracy against him and that the government is targeting him. As a means of spreading the word about this conspiracy, Kevin Perelman created a business card with <a href="MeximPerelmanTarget.com">KevinPerelmanTarget.com</a> printed on the surface. When you access the website on-line, the entire website is dedicated to explaining the 30-year conspiracy against him including video of security guards removing his business cards from vehicles at Gateway Plaza, and random photos of persons or vehicles he believes are part of the conspiracy. An excerpt from his website are included down below in the additional portion of this report and a screen shot of his website heading is depicted in this photo.

# **Kevin Perelman Target**

Targeted for over 30 years

Campaign to remove me from society

In July 2013, I became involved in an investigation where suspect was illegally dumping his business cards and random glow sticks, pornographic material and trash in and around his residence on Julianna Place south of Burbank Blvd in Woodland Hills. Dr#13-2100717. After his case was dispositioned in Los Angeles Municipal Court, it appeared suspect stopped illegally dumping his business cards.


Throughout my assignment as a Senior Lead Officer in Topanga Division I have seen over a thousand of these business cards littered on public/public property and placed on vehicles.

# Investigation:


On April 28, 2016, I received information via social-media that a community member Linda Cannon observed suspect throw handfuls of KevinPerelmanTarget.com business cards out the window of his vehicle. Victim posted the below photo of some of the business cards she collected. Victim stated that at approximately 1330 hrs., she was walking her dog around Warner Center Park, when she observed suspect travelling northbound Owensmouth Avenue, at a slow speed, and begin throwing handfuls of

On March 21<sup>st</sup>, 2017, 1014 hrs., I received a message from Brittany Duffy advising she just collected a bunch of cards of the streets.

"He's littering cards currently, tried to get video but wasn't fast enough"


On May 18, 2017, at approximately 0830 hrs., I contacted Brittany Duffy and she advised that on May 9<sup>th</sup>, 2017 at approximately 2220 hrs., she was seated in her vehicle with a friend when she observed suspect littering his business cards and placing them on vehicles. Suspect walked up to the vehicle she was seated and observed the suspect attempt to place a car on the windshield but he recognized someone was in the care and didn't leave a card. Brittany advised she has taken numerous photos and videos documenting suspect's business cards being littered all over her street.

On 05-18-17, at approximately 1300 hrs., I, Senior Lead Officer Dinse #34920, was assigned 21SL97, Topanga Patrol. On the above date and time, I was en-route to 21620 Burbank Blvd #18 to contact Kevin Perelman at his residence. I was meeting Officer Jurisaga #36897, from LAPD Mental Evaluation CAMP Unit, to assess Kevin Perelman and warn him for the on-going illegal dumping issue.

On the way to the residence, I was advised that a radio call was generated at the location of a "Male Mental". I responded southbound Julianna Place from Burbank Blvd and observed at least 50-100 KevinPerelmanTarget.com business cards on the street and parked vehicles. I met with Officer Cairns #36582 and Compton #42457, learning that Kevin Perelman threatened Victim. I met with Victim Terrance Scroggins and he advised that he was tired of Kevin Perelman littering the area with his business cards. Terrance stated he collected a bunch of the cards, walked over to his unit and placed the cards he collected on his patio table. When Terrance contacted Kevin, he threatened to "Slice him open if he did that again!" Suspect was subsequently arrested for 422 PC (Criminal Threats) Booking #4991549 Dr#17-2110824



# Court Information:

I can testify to the contents of this report.

### Additional:

Request that suspect stop illegally dumping his business cards on the public/private property or placing them on random vehicles as a condition of probation. Suspect placing his business cards in the street, eventually make their way into public water drainage system and end-up in the ocean. These business cards littered in Woodland Hills make their way into the ocean eco-system causing a direct danger to the sea life which could indirectly effect global warming.

Suspect's behavior has escalated from just littering to threatening members of the community due to his belief there is a government conspiracy targeting Kevin Perelman.

Below is an excerpt from the <u>KevinPerelmanTarget.com</u> website he created documenting the 30 plus years of conspiracy to campaign to remove Kevin Perelman from society:


